In the May 2022 issue of *The Philatelikid*, we began brief descriptions of various "Back of the Book" ("BOB") listings in the Scott Catalogues. In subsequent issues we looked at stamps which begin with the letter "B," "C," "CE," "CL," "CM," "CB," "CO," "E," "D," "F," "FA," "J," "K," "L," "LO," "O," "PR," "PN," "PS," "WS," "BK," "Q," "JQ," "QE," "CVP," "WX," "QI," "#X," "REA," and "RV." This month we will look at "RY."

Stamps Beginning with the prefix "RY"

Stamps in the Scott Catalogue with the prefix "RY" are Firearms Transfer Tax stamps. This tax is a federal



revenue collected from licensed gun shop owners and licensed gun dealers when they transfer a gun across state lines by sale, gift, or loan. The National Firearms Act tax went into effect in 1934. It imposed a tax of \$200.00 on the transfer of certain firearms. The Scott Catalogue identifies only 13 different Firearms Transfer Tax stamps. All have a Scott Catalogue value in excess of \$75.00 except the two shown here, Scott RY3 (\$1 green) and Scott RY5 (\$5 red.)



What Is an FFL Transfer?

"FFL" is an acronym for <u>Federal Firearms License</u>. In the US, you must obtain a Federal Firearms License to legally sell, import, or manufacture firearms within your business operations. However, the term "FFL" also commonly refers to a holder of a Federal Firearms License. In the latter case, "FFL" is an acronym for Federal Firearms Licensee. Often used interchangeably, "FFL" refers to either the license itself or the holder of the license. Federal Firearms License transfers require a licensee to turn over the possession of a firearm to another licensee before it may then go to a customer or non-licensee. Therefore, the term "FFL transfer" specifically refers to a firearms sale through a licensed dealer.

The tax on transferring a submachinegun is \$200.00. (See Page 2) This ATF (Alcohol, Tobacco, and Firearms) Form 4 was used on January 26, 2001 to transfer a Smith & Wesson 9mm submachinegun, Model 6, serial number U877. Note that the serial number of the gun is hand-written at the top of the stamp. An enlargement of the stamp is overlaid so that you can see the details.

Scott RY8 - this is in color – the stamp is dark blue. The serial number of the gun is U877, which is hand written at the top of the stamp. For some unknown reason the amount of the tax, \$200.00, is written in the box at lower right marked "Stamp Number." The signature of the Director, at bottom, appears very high, making one wonder if the signature is a hand stamp.
